The undersigned Customer further agrees that, should Great Dane at any time extend credit to the Customer by not requiring full payment of any charges for trailer parts, accessories and/or services at the time of deliver, the Customer shall pay the charges in full within thirty (30) days of the date of invoice. If the Customer fails to do so, the outstanding balance shall bear interest at the rate of one and one-half percent (1 ½%) per month until paid. In the event Great Dane is required to obtain the assistance of an attorney to collect amounts owed to Great Dane by the Customer, whether or not suit is filed, Great Dane will also be entitled to recover all costs of collection, including reasonable attorney’s fees and expenses. All amounts paid to Great Dane shall be applied first to all costs and expenses of collection, then to interest, then to the principal amount of the charges outstanding.
